PARTNERSHIP PORTFOLIO PERFORMANCE SUB-COMMITTEE

TERMS OF REFERENCE

Deriving its authority from the Academic Strategy Committee (ASC), via the University Portfolio Performance Committee (UPPC), the Partnership Portfolio Performance Sub-Committee (PPPSC) is responsible for oversight of performance of courses delivered by the University's UK and International collaborative academic partners.

1. Monitor student outcomes at UK academic partners within OfS, Access and Participation (APP) Teaching Excellence Framework (TEF), National Student Survey (NSS), Postgraduate Taught Experience Survey (PTES) and Postgraduate Research Experience Survey (PRES) key performance metrics for all courses delivered by UK academic partners.
2. Monitor student outcomes at International academic partners within a key performance indicator framework recommended by the sub-committee (and approved by the University Portfolio Performance Committee) for all courses delivered by international academic partners.
3. Recommend institutional priorities and relevant institutional KPI targets for the Partnership Performance Plan for approval by the University Portfolio Performance Committee.
4. Recommend strategic prioritisation of performance of partnerships, or specific courses delivered by partners, that fall within subject groups that are typically considered high impact for the University for approval by Academic Strategy Committee.
5. Review the Partnership Performance Plans (PPPs) for partnerships and courses identified as underperforming in line with agreed Course Performance Plan thresholds so as to recommend to the University Performance Portfolio Committee the strategic intervention required and monitor subsequent progress.
6. Oversee the Partnership Performance Plan sign off process across the institution and carry out selective review of Partnership Performance Plans.
7. Review, and recommend to University Portfolio Performance Committee for approval, the University's Partnership Performance Plan (PPP) template.
8. Provide regular partnership performance progress reports on partnership, and courses within partnerships, performance to the University Portfolio Performance Committee for onward consideration by Academic Strategy Committee, Academic Board, Vice-Chancellor and the Senior Management Team.
