Penal Heritage Briefing Paper Launch




Earlier this year **Maryse Tennant** co-authored 'Penal Heritage: Approaches to Interpretation', a briefing paper for the heritage sector advising about ethical interpretation at former prison sites. This was part of an AHRC/Labex funded project 'Sites of Suffering, Sites of Memory' led by Professor Charles Forsdick at the University of Liverpool. The briefing paper draws on Maryse's work on Canterbury prison heritage as a good practice example and was launched at the Penal and Forensic Heritage event held at the University of Liverpool on 17th October 2018.

Con Son Trip



At the beginning of September **Maryse Tennant** participated in a five day field trip to prison sites on Con Son island, Vietnam along with a team of inter-disciplinary researchers from Nottingham Trent University and the University of Liverpool. There are a number of prison sites on the island, which were used by both the French and the South Vietnamese/American forces during the Vietnam war, and these include the infamous 'Tiger Cages'. As part of this she spoke at a workshop held at Ton Duc Thang University in Ho Chi Minh City about CCCU's redevelopment of the Canterbury prison site and her research on that institution. Computer Science and Smart Currencies




Dr Abhaya Induruwa, Director of the Cyber Innovation Hub, was invited to talk at the 11th International Research Conference held at General Sir John Kotelawala Defence University (KDU), Ratmalana, Sri Lanka on 14th September 2018. Dr Induruwa delivered the plenary speech entitled “**Computer Science and Smart Currencies for the Modern World**” in the session on *Smart Solutions for Global Challenges*. In his speech Dr Induruwa outlined the

benefits of smart currencies (AKA crypto or virtual currencies) and discussed how computer science concepts such as cryptology, databases and data structures have contributed to the development of Blockchain Technology on which Cryptocurrencies are built. He then went on to discuss the challenges brought about by the criminal use of virtual currencies in dark web environments.



How to Stay Safe and Legal On-line



During his recent visit to Saegis Campus, Sri Lanka to deliver staff training and induction programmes **Dr Abhaya Induruwa**, Director of Cyber Innovation Hub, gave a talk to their staff and students on “How to stay safe and legal on the Internet”. In his presentation Dr Induruwa spoke about how criminals carefully and patiently select their prey before launching attacks, and gave examples of recent spam, phishing and spear phishing attack attempts. He then went onto discuss the

emerging threats, especially due to the large scale proliferation of Internet of Things (IoT), now running into tens of billions of ‘things’. Using recent hacks on Internet connected devices such as baby monitors, CCTV cameras, personal fitness monitors, heating and cooling systems as case studies, he explained how hackers can affect normal life and harm people. In particular he warned about the dangers brought about by lack of security in Internet connected soft cuddly toys and how unsuspecting parents and their children can be brought to harm. As part of the University’s commitment to internationalisation the University recently entered into a collaborative partnership with Saegis Campus to offer Canterbury Christ Church University degrees in Sri Lanka. This partnership agreement supports the development, delivery and quality assurance of a range of undergraduate and postgraduate degrees. Initially BSc (Hons) Computing (Top-up), BSc (Hons) Business Management (Top-up), and MBA degrees will be offered. Further development of the portfolio is planned for the future.



On 16 October, **Dr Hannan Azhar**, Senior Lecturer of Computing at CCCU, was invited to the House of Commons, UK Parliament for a morning presentation and discussion on clinical research using innovative technology for improved health and wellbeing for people with brain injury. The meeting was chaired by Dr Mo Sakel, director of neuro-rehab, East Kent Hospital at Canterbury and sponsored and co-chaired by Canterbury MP Rossie Duffield and attended by other distinguished leaders including MP Chris Bryant, clinicians and academics working for rehabilitation across Kent and Medway. Neuro-rehab at the East Kent Hospital have been collaborating with Dr Hannan in several internship projects over past years, which aims to develop BCI assistive system to rehabilitate brain injured patients to increase independence and quality of life. Outcome of the most recent project was presented by Mr Sam Herring, a student intern, at the 9th Brain Injury Conference held 12 October at Kent and Canterbury Hospital. The research was the result of the study on EEG Data filtration methods and feature aggregation from these data sets. The goal was to achieve better success in identification of the visually evoked brain signals for a speller application. Notable increase in accuracy was achieved while using machine learning approaches in modelling classifier systems to detect visually evoked brain signals.



Dr Hannan Azhar, Senior Lecturer at Computing, was invited to the Drone Berlin trade show held in Berlin on 24-25 September 2018, to talk about the challenges and techniques on Drone forensics. The event exclusively focused on drone technology and innovation and was attended by both manufacturers and users of drones including industry leaders, decision makers and government agencies. Dr Hannan, in his talk, indicated the rise in drone related crimes in recent years and discussed techniques in extraction and identification of important artefacts from the recorded flight data of drones, as well as associated mobile devices using open sources tools and some basic scripts. 

Dr Martin O'Neill has published his first single-authored book as part of the *Policy Press Key Themes in Policing* series. The book provides a comprehensive overview and critical analysis of the development and practice of criminal investigation. It examines decision-making within criminal investigations, from volume crime through to major and serious crime investigations and links investigative influences on policing with the evidence-based agenda. Martin has received some excellent reviews for his book, including:

The 4th Edition of *ADR Principles and Practice* by *Brown & Marriott* is due to be published on 31st August 2018. Ben Waters is the lead author and editor of a writing/editorial team of 4, including Henry Brown the original co-author of the text. The 4th edition is aimed at academia and particularly law schools who will be teaching a curriculum with the new Solicitors Training Regulations in mind. Alternative Dispute Resolution (ADR) is increasingly integrated into legal education and training in the UK and many other countries. This edition attempts to produce a more rigorous academic approach to the way ADR is presented, making it useful to academic institutions while at the same time maintaining a practical and pragmatic approach valuable to practitioners. Important changes to solicitors' education and training are about to occur with the introduction of the Solicitors Qualification Examination.



Prof Robin Bryant, together with Dr Roger Arditti from the MPS have published a second article as a result of research conducted into firearms licencing. Entitled 'A wicked problem? Risk assessment and decision-making when licensing possession and use of firearms in Greater London'. It was published in the *Police Journal: Theory, Practice and Principles* in September 2018 (<https://doi.org/10.1177/0032258X18797992>). In June Robin and Roger also published an article in *Police professional* concerning the controversial MPS 'gangs database' ('The Matrix Reloaded? Why we should improve the MPS 'Gang Violence Matrix', not dismantle it'). Robin has also contributed a chapter on 'Innate Reasoning and Critical Incident Decision-Making' in the book 'Decision Making in Police Enquiries and Critical Incidents' which will be published by Palgrave MacMillan in February 2019.
